## CLIENT RESULTS

### Trial Cases

- Won case of first impression in the nation to resolve development dispute between mining and oil and gas interests, allowing the world's largest surface coal mine to protect the viability of its operations. *BTU Western Resources et. al v. Berenergy Corp.*, 2019 WY 57 (2019).

### Appeals

- Won first order in lieu of consent case litigated in over 30 years and secured affirmance on appeal, allowing first coal mine permit application in over 40 years to proceed.

### Site Permitting

- Secured first of its kind permitting exemption for one of the largest combined power and industrial projects in the history of Wyoming.
- Led team that acquired industrial siting permit for Fortune 100 company's state of the art carbon capture project.
- Led team that acquired first-ever industrial siting permit awarded to

a commercial solar and battery storage facility.

- Led the team to permit the largest solar facility in Wyoming.
- Secured industrial siting permits for multiple solar and wind facilities and assisted in subsequent transfers and amendments of those permits.
